At this time the bids will be publicly opened and read aloud to the public.
- Contract time is per the calendar days after the issuance of Notice to Proceed as specified above. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount, or as waived by DPW. Accepted form of bid security may be bid bond, certified check or cashier's check payable to the Treasurer of Guam.
- Bid documents can be obtained at no cost at the office of the Parsons Transportation Group Inc. at 590 South Marine Corps Drive, ITC Building Suite 403, Tamuning, Guam 96913 on the date specified above. All bidders who secured the corresponding bid documents will be officially listed in the Government's Distribution Record as prospective bidders for these construction projects. - The sureties of all bonds must be on the approved listing by the Government of Guam or the United States Department of Treasury listed as "Companies Holding Certificates of Authority as Acceptable Sureties on Federal Bonds and Acceptable Reassuring Companies". The penal amount of the bond shall not exceed the surety's underwriting limit as stated in the Department of Treasury listing. A notarized true copy of Certificate of Authority is also required.
